1. ISETHULO SE-PROMOTION OF ACCESS TO INFORMATION ACT KANYE NE-PROTECTION OF PERSONAL INFORMATION ACT

Ngomhla ka-9 Mashi 2001, i-Promotion of Access to Information Act ("PAIA") yaqala ukusebenza. I-PAIA ifuna ukuthuthukisa isiko lokungafihli lutho nokulandisa ezindikimbeni zomphakathi nezangasese. Lo mthetho wamiswa njengempendulo eqondile yeNgxenye 32(2) yoMthetho-sisekelo waseNingizimu Afrika, obusa ilungelo lokuthola imininingwane, edinga ukuba uHulumeni usebenzise imithetho ngomzamo wokwenza imininingwane ephathelene nezindikimba zomphakathi nezangasese zitholakalele wonke umuntu.

Ngokwemigomo ye-PAIA, i-**DERIVCO (PTY) LTD** ibhekwa "njengenkampani ezimele" yingakho kumelwe ihambisane nezimfuneko ezivamile zokutholakala ezinikezwa ku-PAIA ezihlobene nezinkampani ezimele. Enye yezimfuneko eziyinhloko ezichazwe ku-PAIA, ukuhlanganiswa kwemanyuwali enikeza imininingwane yezinhlobo nezigaba zamarekhodi aphethwe inkampani ezimele nomphakathi.

I-PAIA yenza ilungelo lomthetho-sisekelo lokuthola noma imiphi imininingwane ephethwe uMbuso lisebenze nanoma imiphi imininingwane ephethwe omunye umuntu futhi edingekayo ukuze kusetshenziswe noma kuvikelwe noma imaphi amalungelo. Lapho kwenziwa khona isicelo ngokwemigomo ye-PAIA, indikimba okwenziwa kuyo isicelo inesibopho sokukhipha imininingwane, ngaphandle kwalapho i-PAIA isho khona ukuthi imininingwane ingakhululwa noma akumelwe ikhululwe.

Le Maniwali ihlanganiswa ngokuvumelana nengxenye 51 ye-PAIA njengoba ichibiyelwa yi-Protection of Personal Information Act, 2013 ("POPIA"), eyenza kusebenze ilungelo loMthetho-sisekelo lawo wonke umuntu lephrayivesi. I-POPIA ikhuthaza ukuvikelwa kwemininingwane yomuntu esetshenzwa izindikimba zomphakathi nezangasese, okuhlanganisa izimo ezithile ukuze kusungulwe izimfuneko ezimbalwa zokusetshenzwa kwemininingwane yomuntu. I-POPIA ichibiyela amalungiselelo athile e-PAIA, okubhalansa isidingo sokuthola imininingwane nesidingo sokuqinisekisa ukuvikeleka kwemininingwane yomuntu ngokusiza ukuba kumiswe i-Information Regulator ukuze kusetshenziswe amandla athile futhi kwenziwe imisebenzi nezindima ezithile ngokwemigomo ye-POPIA ne-PAIA, okulungiselela ukukhishwa kwemithetho yokuziphatha nokulungiselelwa amalungelo abantu ngokuqondene nokuxhumana ngokwekhompiyutha kokuzithandela nokwenza isinqumo ngokuzenzakalelayo ukuze kulawulwe ukusebenza kwemininingwane yomuntu futhi kulungiselelwe izindaba ezihlobene nako.
